"A soil remediation project performed by a separate contractor will be ongoing at the site during the time of construction. The scope of soil remediation for P-725 is listed in the "Scope of Work MILCON Soil Excavation." The P-725 soil remediation will remove and replace contaminated soils at the tank farm. The contaminated soils contractor shall be responsible for the removal, transport, storage, and disposal of all contaminated soils encountered at this site."
